If in the future your circumstances change and you no longer pay tax on your income and capital gains tax equal to the tax that the charity reclaims, you can cancel your declaration (see note one). 4. If you pay tax at the higher rate you can claim further tax relief in your self assessment tax return. 5. If you are unsure whether your donation qualifies for Gift Aid tax relief, ask the charity, or you can ask your local tax office for leaflet IR65 'Giving to a charity by individuals'.
